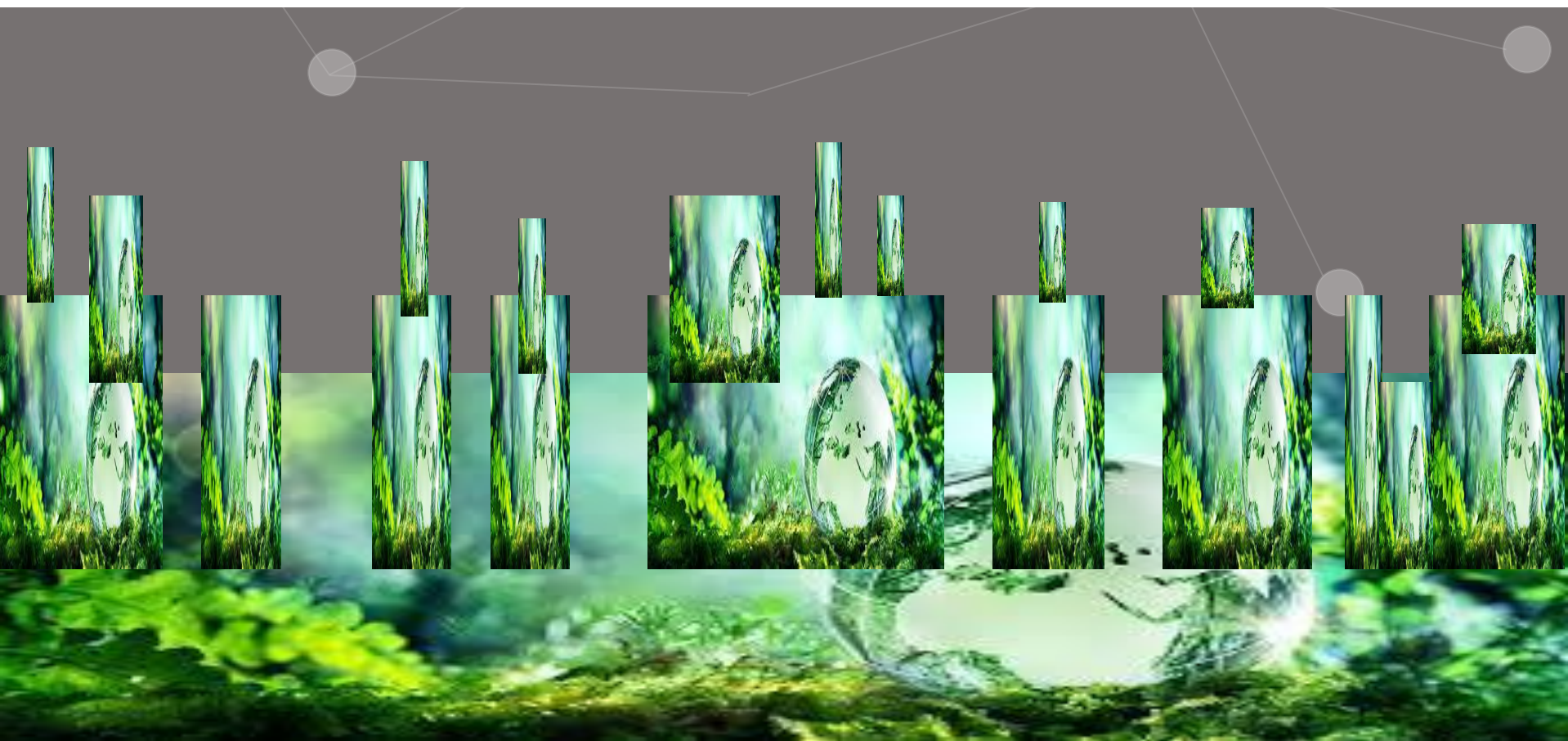


The workshop will empower attendees to initiate the implementation of a sustainable and result oriented energy management programme within their corporations.

Sougata Nandi, *B.Tech., M.Tech.,* Founder & CEO - 3e Advisory

Sougata has successfully set up various businesses in energy management over 20 years in the UAE:

- Energy & Resources Reduction profit centre for ServeU Facility Management, 2003 – 2005
- Sustainable Energy & Environment Division (SEED) for TECOM Group, 2006 – 2011
- Emirates Energy Star for Pacific Controls & Etisalat, 2011 – 2013

Currently, Sougata has his own start-up Energy and Environmental Efficiency Advisory (3e Advisory) whose mission is to “MAKE EVERY CONSUMER AN ENERGY MANAGER”.

Sougata graduated as an Energy Engineer from Indian Institute of Technology (IIT) Kharagpur in 1992. Subsequently, he completed his Masters degree in Energy Engineering from IIT Powai, Mumbai in 1994. Sougata was the second LEED AP from the UAE in 2005 and also became a PMP in 2008.


Sougata started his career as an Energy Engineer with the Energy Management Cell of Confederation of Indian Industry (CII) and conducted several industrial energy audits in various parts of India. After heading CII’s International Office in Kathmandu for two and a half years from 1997 to 1999, Sougata has been involved in energy efficiency, water conservation and green buildings in the UAE since 2000.

While at Tricolour Initiatives, Sougata organized the Region’s first Green Building Conference in Dubai in March 2003 in collaboration with the CERT Technology Park, under the patronage of HH Sheikh Nahayan Mabarak Al Nahyan, the then UAE’s Minister of Higher Education & Scientific Research. Sougata led the Region’s one of the first corporate sustainable development policy initiative for TECOM Group between 2006 and 2011. This program not only reduced energy and water consumption across TECOM Group’s portfolio, but also delivered 5 of the first 12 LEED certified green buildings in the Region. He was also the LEED AP for the third LEED certified project in the Region. His early work on green building certification in Dubai, paved the way for the green building transformation in the UAE.

Subsequently as CEO of Pacific Controls, Sougata led the successful establishment of the Emirates Energy Star (EES) program in collaboration with Etisalat. Within two years EES became the fastest growing energy conservation program in the World.

In addition to winning multiple Awards, Sougata has mentored more than 100 Engineers to become Energy Engineers, many of whom have pursued successful careers in energy management subsequently.
