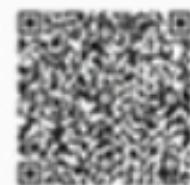

IICSR and Menlo college, Atherton - USA has signed up for course credit transfer for the Masters in information systems course.

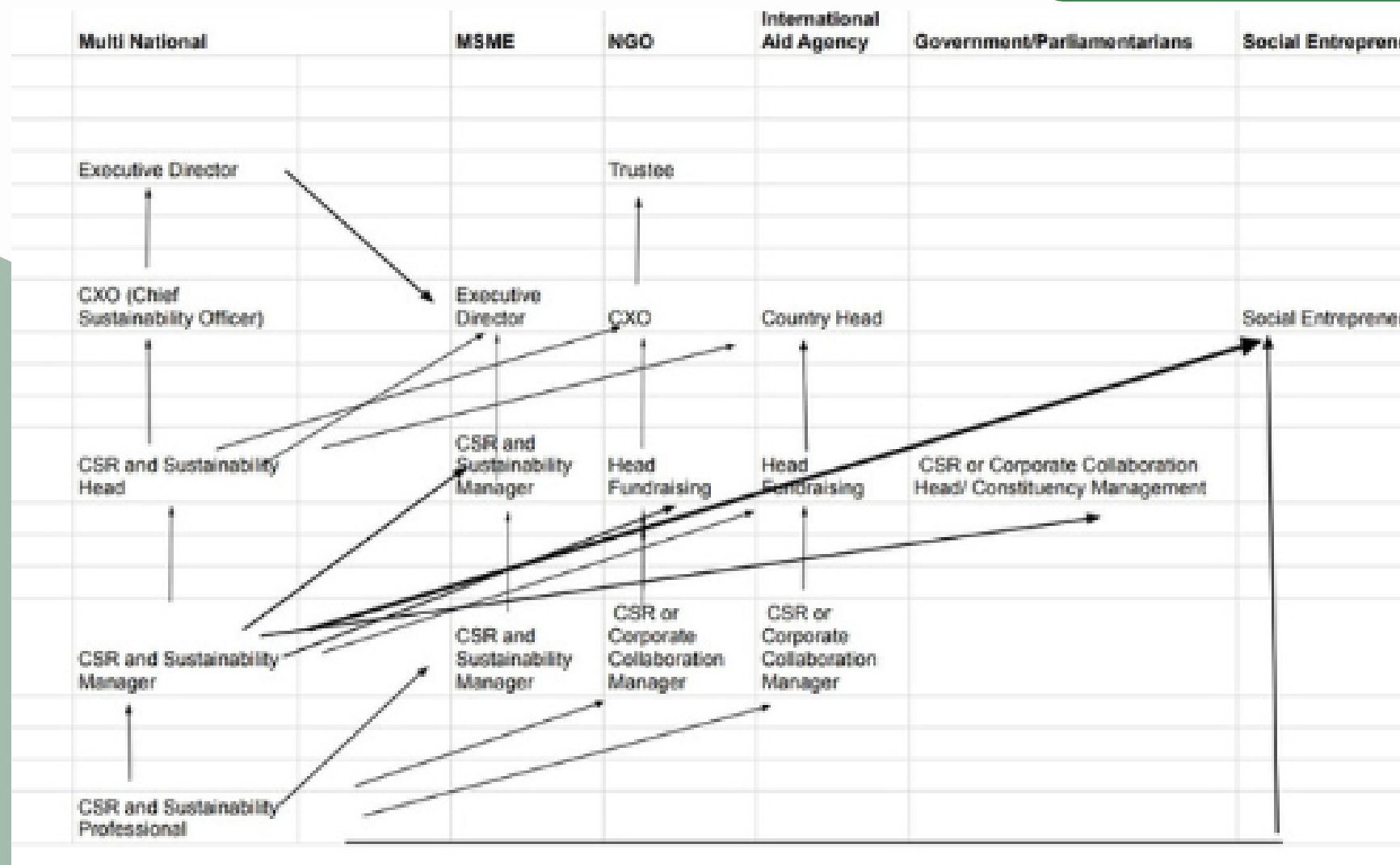

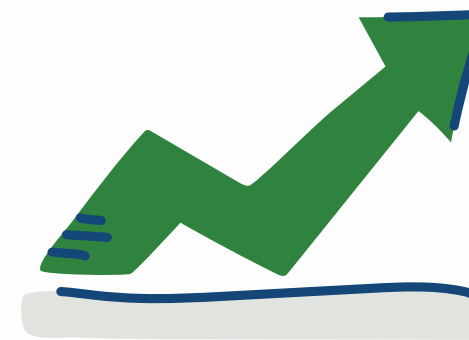

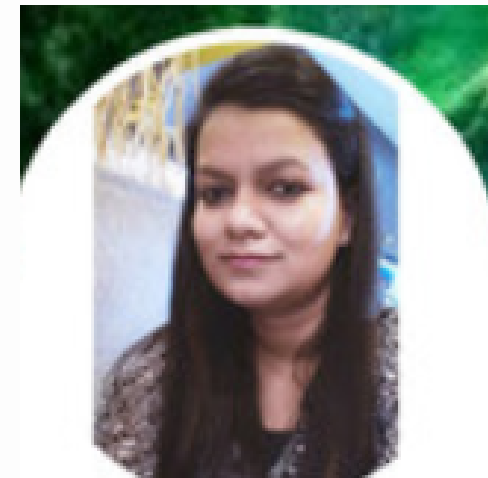
